#### HOPEWELL BOROUGH CERTIFICATION

Will submit it in May. Working as a team to get certification and hopefully some green team members. Heidi is heading up the certification effort and hoping to get social media started for the boro. Writing up a grant proposal for \$2K. Want to reduce curbside items going into the landfill and looking into curbside composting. Joann would like to revisit composting at the March meeting. Dolph is ready for a pilot! Scott thinks the "pay to throw" model incentivizes people to divert from the waste stream.

#### PSEG GRANTS FROM SUSTAINABLE JERSEY

Hopewell Borough? Heidi is submitting a proposal that will include a monthly potluck zero waste event, backyard composting, making the boro more sustainable, and having an event at the train station. The green team is not submitting a proposal this round.

## MERCER COUNTY SUSTAINABILITY COALITION

Green Gathering Report Out. MCIA has a new director, Anthony Verrelli! **COMMUNITY ENERGY PLAN GRANTS FROM BPU** - heard about this at the green gathering. HT is considering applying for a grant to develop community energy plans consistent with the state's energy plan. After you receive the \$10K grant, you meet with Sustainable Jersey experts who look at the possible plans and strategies. Basically, it is getting a resolution passed and putting your name in for consideration. Pennington Borough is putting in for the grant. Hopewell Township may follow suit.
